

Letham Sports Club Tangerine Club “200 Club” Rules

Letham Sports Club Tangerine Club is a private club with the sole intention of raising funds for Letham Sports Club. The initial fundraising activity is a “200 Club” (rules below) and additional fundraising activities may follow as and when required, at later dates.

The Rules of the Letham Sports Club Tangerine Club “200 Club” are as follows:

1. Letham Sports Club Tangerine Club “200 Club” is operated under The Lotteries and Amusements Act 1976, Section 4, Private Lotteries. Letham Sports Club is registered with Perth & Kinross Council under Regulation 3(1)(a) of the Small Society Lotteries (Registration of Non-Commercial Societies) Regulation 2007, to undertake this activity.
2. The objective is to have at least 200 members (minimum age 16) although the Club will be organised with any number deemed viable by the Promoter on behalf of Letham Sports Club Executive Committee.
3. Letham Sports Club reserves the right to amend these rules from time to time, as necessary. A current copy of the rules is available from the Promoter and on the website www.lethamfc.com
4. The first “200 Club” draw will take place on Sunday 25 September 2011. Subsequent draws will take place on the last Sunday of each month. The “200 Club” year will run from 1st September to 31st August.
5. All proceeds after the payment of prizes and expenses will be for the purposes of meeting Letham Sports Club expenses and development.
6. The subscription will be £5/month payable by standing order on the 2nd working day of each month (or annually by a single payment of £60 to be paid before the 5th working day in September each year. Members joining during the lottery year and wishing to pay by cheque will pay a pro-rata amount of £5 for each month up to August in the relevant year). On receipt of a single annual payment or standing order form, the applicant will be allocated a unique membership number. For each additional £5 paid per month, an additional number will be allocated.
7. No “200 Club” participants will be included in the draw if the appropriate payment has not been received by the 5th working day of the month in which the draw takes place.
8. Winners will be paid by cheque sent by post to the person named as the holder of the winning number. Cheques not cashed within six months will be regarded as a donation to Letham Sports Club. Notification of winners will appear on the Letham FC website and local press.
9. The draw will be conducted by 3 people, one of whom will be the Promoter or other member of the Letham Sports Club Executive Committee. All members are entitled to attend any draw. The draw will normally be undertaken by an automatic random number generator or other means deemed appropriate.
10. In the event of 200 members, the prize structure will be as follows: 1 prize of £200, followed by 1 x £100, 1 x £50 and 1 x £25. There will also be a “Bonus Draw” of £1000 every 10 months, occurring in June 2012 in the first full year of the “200 Club”. Prizes will be scaled up or down, rounded to the nearest £1, dependant on the actual numbers within the “200 Club”.
11. Participants can cancel their entry in the “200 Club” at any time by giving one month’s written notice to the Promoter. If paying by standing order, they should advise their bank. Under no circumstances can payments be refunded.
12. The “200 Club” Promoter will make the final decision. Appeals can be made to the Letham Sports Club Executive Committee.
